# On local sharply $n$-transitive groups <br> M. V. Neshchadim and A. A. Simonov 


#### Abstract

The paper is devoted to generalizations of actions of topological groups on manifolds. Instead of a topological group, we consider a local topological group generalizing the notion of a germ or a neighborhood in a topological group. The notion of an action of a local group on a topological space is introduced.

The paper constructs the theory of local sharply $n$-transitive groups and local $n$-pseudofields. Local sharply $n$-transitive groups are reduced to simpler algebraic objects - local $n$-pseudofields, similarly to the way Lie groups are reduced to Lie algebras, and sharply two-transitive groups, are reduced to neardomains. This can be useful, since, opposite to locally compact and connected sharply $n$-transitive groups, which are absent for $n>3$, local sharply $n$-transitive groups exist for any $n$, for example, the group $G L_{n}(\mathbb{R})$. Being boundedly sharply $n$-transitive, the groups under consideration are also Lie groups, which gives extra methods for their study.

## 1 Introduction

C. Jordan [1] discovered in 1872 that among finite groups, with the exception of the symmetric groups $S_{n}$, alternating groups $A_{n+2}$ and Mathieu groups $M_{11}$ and $M_{12}$, there are no sharply $n$-transitive groups for $n>3$.

In 1931 Carmichael [2] came to the conclusion that finite sharply 2-transitive permutation groups are groups of affine transformations $x \mapsto x b+a, b \neq 0$, of a finite nearfield. In 1936 Zassenhaus [3, 4] recovered this result and in addition showed that every finite sharply 3 -transitive group is isomorphic to a group of transformations $x \mapsto \frac{x b+a}{x d+c}$ with suitable conditions on $a, b, c, d$ over a field $\mathbb{F} \bigcup\{\infty\}$ and, in certain cases, over a nearfield.

Tits [5] showed that if a sharply 2 -transitive group is locally compact and connected and acts on a topological space, then it is isomorphic to the group of transformations $x \mapsto x b+a, b \neq 0$, of the field of real numbers $\mathbb{R}$, or the field of complex numbers $\mathbb{C}$, or the skew-field of quaternions $\mathbb{H}$. In this case a sharply 3 -transitive group is isomorphic to the group of transformations $x \mapsto \frac{x b+a}{x d+c}$ with the condition $a d-c b \neq 0$. Such a group can be constructed only over the fields $\mathbb{R}$ or $\mathbb{C}$. In spite of the absence of infinite sharply $k$-transitive groups for $k>3$, it is known [6] that infinite $k$-transitive but not $(k+1)$-transitive groups exist for arbitrary $k$.

If we do not require the group to be locally compact and connected, then a sharply 2-transitive group is isomorphic to the affine group of transformations $x \mapsto$ $x b+a$ of some pseudo-field. At the beginning of the 1950s Tits [7] defined a pseudofield as an algebraic system $\mathbb{B}=\left\langle B ; \cdot,+,^{-1},-, 1,0\right\rangle$ with two binary operations satisfying the following axioms:

1) $\langle B ;+,-, 0\rangle$ is a magma with neutral element 0 ;
2) $a+(-a)=0 \Rightarrow(-a)+a=0$;
3) $\left\langle B_{1} ; \cdot,^{-1}, 1\right\rangle$ is a group with neutral element 1 , where $B_{1}=B \backslash\{0\}$;
4) $x \cdot 0=0 \cdot x=0$;
5) $(x+y) \cdot z=x \cdot z+y \cdot z$;
6) $\left(\exists r_{a, b} \in B_{1}\right)$ such that $(x+a)+b=x \cdot r_{a, b}+(a+b)$ for any $x \in B$.

Isomorphic sharply 2 -transitive groups can be constructed over non-isomorphic pseudo-fields. To avoid such a situation, in the mid-1960s Karzel [7, 8] introduced a similar algebraic system, a neardomain, as a system $\mathbb{B}$ with two binary operations. Here, axiom 1) was strengthened and axiom 4) was changed:
$\left.1^{*}\right)\langle B ;+,-, 0\rangle$ is a loop with neutral element 0 ;
$\left.4^{*}\right) x \cdot 0=0$.
Along with the generalization of a nearfield to a neardomain, a KT-field was introduced in [9] for the construction of sharply 3 -transitive groups in the infinite case. This is a pair $(\mathbb{B}, \varepsilon)$, where $B$ is a neardomain and $\varepsilon$ is an automorphism of the group $B_{1}$. This automorphism satisfies the identity

P.M. Cohn [10, Lemma 7.5.1.] considered an equivalent definition of a skew-field $\mathbb{F}=\left\langle F ; \cdot,+,^{-1},-, 1,0\right\rangle$, which he constructed using a unary operation $\varphi: F_{0} \rightarrow F_{0}$ acting on a multiplicative group $\mathbb{F}_{1}=\left\langle F_{1} ; \cdot{ }^{-1}, 1\right\rangle$, where $F_{0}=F_{1} \backslash\{1\}$. The operation $\varphi$ satisfies the following axioms:

1. $\varphi\left(y x y^{-1}\right)=y \varphi(x) y^{-1}, x, y \in F_{0}$;
2. $\varphi(\varphi(x))=x, x \in F_{0}$;
3. $\varphi\left(x y^{-1}\right)=\varphi\left(\varphi(x)(\varphi(y))^{-1}\right) \varphi\left(y^{-1}\right), x, y \in F_{0}, x \neq y ;$
4. the element $b=\varphi\left(x^{-1}\right) x(\varphi(x))^{-1}$ does not depend on the chosen $x \in F_{0}$.

Here it turns out that $b=-1$ and $\varphi(x)=1-x$.
W. Leissner obtained similar results independently (see [11]). He also showed in [12] that when only part of the requirements on the function $\varphi: B_{0} \rightarrow B_{0}$ were applied, one could obtain a nearfield (using only Axioms 2, 3 , and 4) or a neardomain (only by Axioms 2 and 3).

When developing his approach with a view to constructing sharply $(k+1)$ transitive groups, instead of a single automorphism $\varepsilon \subseteq \operatorname{Aut}\left(\mathbb{B}_{1}\right)$ with condition (1) for a KT-field, Leissner included a symmetric group of automorphisms $S_{k-1} \subseteq$ Aut $\left(\mathbb{B}_{1}\right)$ such that $S_{k}=\left\langle\varphi, S_{k-1}\right\rangle .{ }^{1}$ By using such an algebraic system Leissner constructed the sharply $n$-transitive groups $S_{n}, S_{n+1}, A_{n+2}$ and the sharply 4- and 5-transitive Mathieu groups $M_{11}, M_{12}$. He called the algebra that he introduced a $\mathbb{B}_{1}$-field of degree $n$ (see [13]), where $\mathbb{B}_{1}$ is the multiplicative group over which the field of degree $n$ is constructed. For example, a $\mathbb{B}_{1}$-field of degree 3 is associated with a KT-field.

In [14], A. A. Simonov constructed a generalization of sharply $n$-transitive groups to boundedly sharply $n$-transitive groups. Among them, there are local sharply 2 transitive groups that cannot be constructed over local neardomains.

[^0]The paper develops the theory of local sharply $n$-transitive groups and local $n$-pseudofields in line with [12, 13] and [14]. Local sharply $n$-transitive groups are reduced to simpler algebraic objects - local $n$-pseudofields. It can be useful because, opposite to locally compact and connected sharply $n$-transitive groups, which are absent for $n>3$, there are local sharply $n$-transitive groups for arbitrary $n$, for example, the group $\mathrm{GL}_{n}(\mathbb{R})$.

In Section 2, we give the definitions of a local group, a local group isomorphism, a continuous group of transformations, and a local $n$-pseudofield.

Section 3 contains the main constructions. A local sharply 2-transitive group is constructed in Theorem 1 from a local pseudofield. Then the result is extended, and a local sharply $n$-transitive group is constructed from a local $n$-pseudofield in Theorem 2.

At the next step, Theorem 3 is applied to solve the inverse problem - a local $n$-pseudofield is constructed from a local sharply $n$-transitive group. The section is finished by Theorem 4, which proves the equivalence of the categories of local sharply $n$-transitive groups and local $n$-pseudofields.

We now explain our terminology. To describe sharply 2 -transitive groups, in [5], Tits introduced the algebraic system, a pseudofield, as the generalization of the concepts of a field, a skew-field, and a nearfield. But later, a close concept, a neardomain, was applied for describing such groups, and so the term pseudofield got vacant. In [13], Leissner introduced the notion of a G-field of degree $n$ for describing sharply $n$-transitive groups. In this article, following the previously introduced notion of an $n$-pseudofield (see [14]), we define a local $n$-pseudofield for describing the algebraic systems associated with local sharply $n$-transitive groups.

## 2 Definitions

### 2.1 A local group

Give the definition of local topological groups and a local isomorphism (see [15, §23]):

Definition $1 A$ topological space $G$ is called a local group if the product $a b \in G$ is defined for some pairs $a, b$ of elements of $G$; moreover, the following conditions must be satisfied:
(1) If the products $a b,(a b) c, b c, a(b c)$ are defined then the equality $(a b) c=a(b c)$ holds.
(2) If the product $a b$ is defined then, for every neighborhood $W$ of ab, there are neighborhoods $U$ and $V$ of $a$ and $b$ respectively such that if $x \in U$ and $y \in V$ then the product $x y$ is defined and $x y \in W$.
(3) $G$ contains a distinguished element $e$, called the unit, such that if $a \in G$ then the product ea is defined and ea $=a$.
(4) If the product $a b$ is determined for $a$ pair $a, b$ and $a b=e$ then $a$ is said to be the left inverse for $b, a=b^{-1}$. If $b$ has a left inverse then, for every neighborhood $V$ of $b$, there is a neighghborhood $U$ of $b^{-1}$ such that each $y \in V$ has a left inverse $y^{-1} \in U$.

Let $G$ be a local group. Refer to any neighborhood $U$ of the unit $e$ in $G$ as a part of the local group $G$. Every part $U$ of a local group $G$ is itself a local group with the operations induced from $G$.

Definition 2 Let $G$ and $G^{\prime}$ be two local groups and let $U$ and $U^{\prime}$ be their parts. A mapping $f$ is said to be a local isomorphism from $G$ onto $G^{\prime}$ if $f$ is a homeomorphism from $U$ onto $U^{\prime}$ and the following conditions hold:
(1) If the product $a b$ is defined in $U$ then the product $f(a) f(b)$ is defined in $U^{\prime}$ and $f(a b)=f(a) f(b)$.
(2) $f$ takes the unit into the the unit.
(3) $f$ is invertible, and its inverse $f^{-1}$ satisfies the same conditions as $f$.

If there is a local isomorphism from a local group $G$ onto a local group $G^{\prime}$ then $G$ and $G^{\prime}$ are said to be locally isomorphic.

Two local isomorphisms of $f$ and $f^{\prime}$ of a group $G$ onto a group $G^{\prime}$ are called equivalent if they coincide on some part of $G$. Below we will analyze local isomorphisms only up to equivalence.

Let us give also the definitions of the groups of transformations [15, §24]:
Definition 3 A topological group $G$ is called a continuous group of transformations of a topological space $\Gamma$ if for any element $x \in G$ there corresponds a transformation $x^{*}$ of $\Gamma$ so that $(x y)^{*}=x^{*} y^{*}$ and the function $\sigma$ of two variables $x \in G$ and $\xi \in \Gamma$ defined by the relation $\sigma(x, \xi)=x^{*}(\xi)$ is continuous, i.e. gives a continuous mapping of the direct product $G \times \Gamma$ of the topological spaces $G$ and $\Gamma$ onto $\Gamma$.

If different elements in the group $G$ give different transformations then $G$ is called an effective group of transformations. In this case, the elements $G$ can be treated as transformations $\left(x=x^{*}\right)$.

A continuous group $G$ of transformations of a space $\Gamma$ is called transitive if the abstract group $G$ of transformations of $\Gamma$ is transitive.

Henceforth, by a continuous group of transformations we mean a pair $(\Gamma, G)$, where $G$ is a topological group and $\Gamma$ is a topological space. Let us now consider mappings $\psi: G \rightarrow G^{\prime}$ and $\chi: \Gamma \rightarrow \Gamma^{\prime}$.

Definition 4 A pair of mappings $(\chi, \psi)$ is called a similarity of the pair $(\Gamma, G)$ onto the pair $\left(\Gamma^{\prime}, G^{\prime}\right)$ if $\psi: G \rightarrow G^{\prime}$ is a group isomorphism, $\chi: \Gamma \rightarrow \Gamma^{\prime}$ is a homeomorphism of topological spaces, and

$$
\chi[g(x)]=\psi(g)(\chi[x]),
$$

where $g \in G, x \in \Gamma$.
If there is a pair of mappings $(\chi, \psi)$ that is a similarity of $(\Gamma, G)$ and $\left(\Gamma^{\prime}, G^{\prime}\right)$ then the pairs $(\Gamma, G),\left(\Gamma^{\prime}, G^{\prime}\right)$ are called similar.

Definition 5 Call a continuous group of transformations $(\Gamma, G)$ acting on a space $\Gamma$ as locally sharply n-transitive if $G$ is a local group acting on some open subspace $M \subset \Gamma^{n}$ sharply transitively.

### 2.2 A local pseudofield

Consider the symmetric group $S_{n}$ and a group of transformations ( $G, S_{n}$ ), acting locally $G \times S_{n} \rightarrow G$ in the space $G$. In other words, local homeomorphisms $f_{\alpha}$ are defined in $G$; they are indexed by elements $\alpha \in S_{n}$ for which $f_{\beta}\left(f_{\alpha}(x)\right)=f_{\alpha \cdot \beta}(x)$.

It is known that $S_{n}$ is generated by the transpositions $(1, i)$, where $i=2,3, \ldots, n$. Note that

$$
(1, i)(1, j)(1, i)=(1, j)(1, i)(1, j)=(i, j) \quad \text { for } \quad i \neq j
$$

Denote the involute local homeomorphisms defined by transpositions as follows:

$$
f_{(1, i)}=\varphi_{i}, \text { for }(i=2, \ldots, n)
$$

The binary operation $(\cdot): G \times G \rightarrow G$ is defined almost everywhere in $G^{2}$ and its restriction to $G_{1}$ gives the local structure $\left\langle G_{1} ; \cdot, E, e\right\rangle$ on $G_{1} \subset G$. Using the local homeomorphisms $\varphi_{i}$, from the local group $\left\langle G_{1} ; \cdot, E, e\right\rangle$, construct the locally isomorphic groups

$$
\varphi_{i}:\left\langle G_{1} ; \cdot \cdot, E, e\right\rangle \mapsto\left\langle G_{i} ; \cdot{ }_{i}, E_{i}, e_{i}\right\rangle,
$$

where $E(x)=x^{-1}$ is the local homeomorphism of taking the inverse in the group $G_{1}$, and

$$
x \cdot_{i} y=\varphi_{i}\left(\varphi_{i}(x) \varphi_{i}(y)\right), \quad E_{i}(x)=\varphi_{i}\left(E\left(\varphi_{i}(x)\right)\right)
$$

are the multiplication and the inverse taken in $G_{i} ; e, e_{i}=\varphi_{i}(e)$ are the local units of the local groups $G_{1}$ and $G_{i}$ respectively.

Definition 6 Say that a group of transformations $\left(G, S_{n}\right)$ defines a local n-pseudofield $\left\langle G ; \cdot, E, \varphi_{2}, \ldots, \varphi_{n}, e\right\rangle$ if the following conditions are fulfilled:

1. if the products $a \varphi_{i}\left(b^{-1}\right), \varphi_{i}\left(a \varphi_{i}\left(b^{-1}\right)\right) b, a \cdot{ }_{i} b$, are defined then

a \cdot_{i} b=\varphi_{i}\left(\varphi_{i}(a) \varphi_{i}(b)\right)=\varphi_{i}\left(a \varphi_{i}\left(b^{-1}\right)\right) b ; \tag{2}
\end{equation*}

2. if the product $a \cdot{ }_{i} b$ is defined then, for every neighborhood $W$ of the element $a \cdot{ }_{i} b$ there exist neighborhoods $U$ and $V$ of $a$ and $b$ such that for $x \in U, y \in V$ the products $x \cdot i y, x \varphi_{i}\left(y^{-1}\right), \varphi_{i}\left(x \varphi_{i}\left(y^{-1}\right)\right) y$ are defined and $x \cdot{ }_{i} y=\varphi_{i}\left(x \varphi_{i}\left(y^{-1}\right)\right) y \in$ $W$.
3. The local homeomorphism $\sigma_{i j}=\varphi_{j} \varphi_{i} \varphi_{j}$ for $i \neq j$ is a local automorphism of the group $G_{1}$.
4. If $\varphi_{i} E \varphi_{i}(a)$ and $E \varphi_{i} E(a)$ are defined for some $a \in G$ then

\varphi_{i} E \varphi_{i}(a)=E \varphi_{i} E(a)
$$

5. The elements $e_{i}=\varphi_{i}(e) \in G$ are left zeros for the binary operation in $G$, i.e., $e_{i} \cdot x=e_{i}$, for $x \in U$ from a neighborhood of the unit $e \in G_{1}$.

Equation (2) can be written down as a relation between two group operations:

for $a \in G, b \in V \subset U \cap \varphi_{i}(U)$.

## 3 Basic constructions

### 3.1 A local sharply 2-transitive group

Theorem 1 From a local 2-pseudofield $\left\langle G ; \cdot, E, \varphi_{2}, e\right\rangle$, one can construct a local sharply 2-transitive group of transformations $\left(G, G^{2}\right)$.
$1^{0}$. Consider the topological space $G$ and its square $G^{2}$. Separate neighborhoods $U, U_{2} \subset G ; W, W_{2} \subset G^{2}$ of the local units $e \in U, e_{2} \in U_{2}=\varphi_{2}(U), W \subset G \times U$, $W_{2} \subset U_{2} \times G$, such that the following hold for arbitrary $x \in G,\left(y_{1}, y_{2}\right) \in W$ and $x^{\prime} \in U_{2},\left(y_{1}^{\prime}, y_{2}^{\prime}\right) \in W_{2}$ :

\varphi_{2}\left(y_{1} y_{2}^{-1}\right) \in U, \quad \varphi_{2}\left(x \varphi_{2}\left(y_{1} y_{2}^{-1}\right)\right) y_{2} \in G
$$

and

Define the functions $f_{i}: G \times G^{2} \rightarrow G$,

For $x \in G,\left(y_{1}, y_{2}\right) \in W \cap W_{2}$, both functions $f_{1}\left(x, y_{1}, y_{2}\right)$ and $f_{2}\left(x, y_{1}, y_{2}\right)$ are defined and coincide with account taken of (2):

For $x=e$ and $\left(y_{1}, y_{2}\right) \in W$, we have

For $x=e_{2}$ and $\left(y_{1}, y_{2}\right) \in W_{2}$, by analogy, we have the second function:

Consider the function $f_{2}$ for $x \in U, y \in U \cap U_{2}$ :

Further define a binary local operation $\left(\mathrm{o}_{2}\right): G^{2} \times G^{2} \rightarrow G^{2}$ as follows:

For convenience, we do not differ the pairs from $G^{2}$ written as a column $\binom{x_{1}}{x_{2}}$ and a row $\left(x_{1}, x_{2}\right)$.
$2^{0}$. Check condition (1) of Definition 1 of a local group (the associativity of the product of pairs):

The transformation of $\varphi_{2}$ has led to a representation of the $i$ th component already of the product $\left(\left(x_{1}, x_{2}\right) \circ_{2}\left(y_{1}, y_{2}\right)\right) \circ_{2}\left(z_{1}, z_{2}\right)$ so that the local operation (its local nature will be checked later) $o_{2}$ is associative, and so it one can assert that $\left\langle G^{2} ; o_{2}\right\rangle$ is a local semigroup.
$3^{0}$. Let us check condition (2) of Definition 1 of a local group.
Suppose that the value $f(a, b, c)$ is defined for some $a, b, c$. Since a local group and a group isomorphic to it with multiplication $\left(\cdot_{2}\right)$ are defined in $G$, for every neighborhood $W_{1}$ of the element $c b^{-1}$, there are neighborhoods $U_{1}$ and $V_{1}$ of $c$ and $b^{-1}$ such that the product $x y$ is defined for $x \in U_{1}, y \in V_{1}$ and $x y \in W_{1}$. Then, for every neighborhood $W_{2}$ of $a^{\prime} \cdot{ }_{2} b^{\prime}$, there are neighborhoods $U_{2}$ and $V_{2}$ of $a^{\prime}$ and $b^{\prime}$ such that the product $x \cdot{ }_{2} y$ is defined for $x \in U_{2}, y \in V_{2}$ and $x \cdot{ }_{2} y \in W_{2}$. And finally, for every neighborhood $W_{3}$ of $a^{\prime \prime} b^{\prime \prime}$, there are neighborhoods $U_{3}$ and $V_{3}$ of $a^{\prime \prime}$ and $b^{\prime \prime}$ such that the product $x y$ is defined for $x \in U_{3}, y \in V_{3}$ and $x y \in W_{3}$. Then, by superposition, for an arbitrary neighborhood $W=W_{3} \ni f(a, b, c)$, there exist neighborhoods $U=\varphi_{2}\left(U_{2}\right), V^{\prime} \subseteq V_{3} \cap E\left(V_{1}\right), V \subseteq U_{1}$, with $V_{2} \subseteq W_{1}, U_{3} \subseteq W_{2}$ such that $f(x, y, z) \in W$ holds for arbitrary $x \in U, y \in V^{\prime}, z \in V$.

Condition (4) of Definition 1 of the local group follows from the superposition of the local group operations, the local nature of the transformations $\varphi_{2}$, and taking the inverse in the local group. As a result, $\left\langle G^{2} ; o_{2}\right\rangle$ is a local group. The theorem is proved.

Note that the group $G$ is embedded in $G^{2}$ as $G \ni x \mapsto\left(x, e_{2}\right) \in G^{2}$, and the image of $G$ under this embedding coincides with the stabilizer $G \simeq\left(G^{2}\right)_{e_{2}}$ of $e_{2}$ in $G^{2}$, as follows from (7) and the definition of function (8).

As an example of a group $G$, consider the multiplicative group $\mathbb{R}^{*}$ and the function $\varphi_{2}(x)=-x+1$. The corresponding group $G^{2}$ is constructed with the use of the function $f(x, a, b)=x(a-b)+b$ and is isomorphic to the affine group of transformations of the set $\mathbb{R}$.

### 3.2 Infix-postfix notation

Above, using a homeomorphism $\varphi_{2}$ and a group of transformations $(G, G)$, we constructed a group ( $G, G^{2}$ ). Considerating $n$-pseudofields, as $n$ grows from 2 to 3 and more, the number of parentheses rises substantially. To avoid their complication, we will use the combined infix and postfix notation of formulas.

The postfix notation for a group can be written as group action on itself $G \times G^{\prime} \rightarrow$ $G$. For instance, the binary operation of multiplication in $G$ can be written as a function (or a unary operation) $x \cdot y \equiv f_{y}(x)$, whereas, in the postfix notation, it is done through the right action $f_{y}(x) \equiv x \bullet[y]$, where $x \in G,[y] \in G^{\prime}$. For multiplying three elements, we have

Thus, (27) defines the inverse in the local group $G^{n}$.
The constructed local group $G^{n}$ is sharply transitive under the action on itself. Hence, as a local group of transformations $G^{n}$ of $G$, it is sharply $n$-transitive.
The theorem is proved.
Thus, we have consrtructed a mapping $F_{2}:\left\langle G, \varphi_{2}, \ldots, \varphi_{n}\right\rangle \rightarrow\left(G, G^{n}\right)$, i.e., a procedure that, given an arbitrary $n$-pseudofield $\left\langle G, \varphi_{2}, \ldots, \varphi_{n}\right\rangle$, constructs the corresponding group of transformations $\left(G, G^{n}\right)$.

### 3.4 Examples

As a simplest example of a local sharply 2-transitive group, consider the group of affine transformations of the field of real or complex numbers $x \rightarrow x a+b$, for which the corresponding group $T_{2}$ can be written as

Here $(1,0)$ is the neitral elment. The corresponding local 2-pseudofield is written down with the use of the function $\varphi_{2}(x)=-x+1$ acting on the multiplicative group $G$.

Extending this example to the case $n=3$, pass to the locally isomorphic group $\psi: G \rightarrow G^{\prime}$ by means of the transformation $\psi(x)=\frac{2 x}{x+1}$ and its inverse $\psi^{-1}(x)=\frac{x}{2-x}$ so that the multiplication in $G^{\prime}$ has the form

$$
x \iota^{\prime} y=\frac{2 x y}{1+x+y-x y}
$$

with the functions

$$
\varphi_{2}^{\prime}(x)=\psi^{-1} \varphi_{2} \psi(x)=\frac{1-x}{1+3 x} \text { and } \varphi_{3}^{\prime}(x)=-x
$$

acting on this group and $e_{1}^{\prime}=1, e_{2}^{\prime}=0, e_{3}^{\prime}=-1$. In this case, the group multiplication in $T_{3}$ can be written through the tuple function

$$
x \bullet\left[y_{1}, y_{2}, y_{3}\right]=\frac{x\left(2 y_{1} y_{3}-y_{2}\left(y_{1}+y_{3}\right)\right)+y_{2}\left(y_{3}-y_{1}\right)}{x\left(y_{1}-2 y_{2}+y_{3}\right)+y_{3}-y_{1}} .
$$

Other examples for the groups $T_{n}$ of transformations of $\mathbb{R}^{2}$ for $n \leq 4$ can be found in [17].

The group $G L_{n}(\mathbb{R})$ is an example of a local sharply $n$-transitive group of transformations in $\mathbb{R}^{n}$ constructed by means of the local $n$-pseudofield with distinguished elements

$$
e_{1}=(1,0, \ldots, 0), e_{2}=(0,1,0, \ldots, 0), \ldots, e_{n}=(0, \ldots, 0,1),
$$

fromy the multiplicative group $G$ with the multiplication

$$
\left(x_{1}, x_{2}, \ldots, x_{n}\right)\left(y_{1}, y_{2}, \ldots, y_{n}\right)=\left(x_{1} y_{1}, x_{1} y_{2}+x_{2}, \ldots, x_{1} y_{n}+x_{n}\right)
$$

and the functions $\varphi_{i}$ which, under the action at the row $\left(x_{1}, \ldots, x_{n}\right)$, replace two elements $x_{1}$ and $x_{i}$ leaving the remaining coordinates fixed.

Using the same group $G$ and the same functions $\varphi_{i}$ for $i<n$ but $\varphi_{n}$, which is replaced by

$$
\varphi_{n}\left(x_{1}, \ldots, x_{n}\right)=\left(1-x_{1}-x_{2}-\ldots-x_{n-1}, x_{2}, \ldots, x_{n}\right)
$$

the Mikhaulichenko group $T_{n}$ is constructed [18]; it is nonisomorphic to $G L_{n}$ but embeddable in $G L_{n+1}$.

### 3.5 A local $n$-pseudofield

Let us show that it is possible to construct a local $n$-pseudofield from a local sharply $n$-transitive group. Namely, we have the following assertion:

Theorem 3 Given a local sharply n-transitive group $T_{n}$ of transformations of a set $G$, it is possible to construct a local n-pseudofield from $T_{n}$.
$1^{0}$. Since $T_{n}$ is a local sharply $n$-transitive group, the stabilizer of arbitrary $n$ of various elements from $G$ is trivial. Consider $n$ different elements $e_{1}, \ldots, e_{n}$ from $G$ for which there is a nontrivial stabilizer of $e_{2}, \ldots, e_{n}$. Fix this collection $\left[e_{1}, \ldots, e_{n}\right]$.

The action of the group $T_{n}$ on $G$ is written as $a \mapsto a \cdot x$, where $x \in T_{n}, a \in G$. Define a structure of a local group on $G^{n}$. With an element $x \in T_{n}$, associate a tuple $\left[x_{1}, \ldots, x_{n}\right]$ from $G^{n}$ by the rule

$$
\left[x_{1}, \ldots, x_{n}\right]=\left[e_{1} \cdot x, \ldots, e_{n} \cdot x\right]=\left[e_{1}, \ldots, e_{n}\right] \cdot x
$$

Then the neutral element $e \in T_{n}$ element determines the tuple $\left[e_{1}, \ldots, e_{n}\right] \in G^{n}$. Define the multiplication operation of such sets in accordance with the rule:

& {\left[x_{1}, \ldots, x_{n}\right]\left[y_{1}, \ldots, y_{n}\right]=\left[e_{1}, \ldots, e_{n}\right] \cdot(x y)=\left[x_{1}, \ldots, x_{n}\right] \cdot y } \\
&=\left[x_{1} \cdot y, \ldots, x_{n} \cdot y\right]=\left[x_{1} \cdot\left[y_{1}, \ldots, y_{n}\right], \ldots, x_{n} \cdot\left[y_{1}, \ldots, y_{n}\right]\right] \tag{28}
\end{align*}
$$

where we use that, owning to the correspondence $T_{n} \ni x \mapsto\left[x_{1}, \ldots, x_{n}\right] \in G^{n}$, the elements of the group $G^{n}$ act at elements of $G$ by the rule

$$
a \cdot\left[x_{1}, \ldots, x_{n}\right] \equiv a \cdot x, \text { где } a \in G, x \in T_{n} .
$$

By construction, the local groups $T_{n}$ and $G^{n}$ are locally isomorphic.
The action of $G^{n}$ at the elements $e_{i}$ follows from the identity

\begin{align*}
& {\left[e_{1}, \ldots, e_{n}\right] \cdot\left[x_{1}, \ldots, x_{n}\right]} \\
& \quad=\left[e_{1} \cdot\left[x_{1}, \ldots, x_{n}\right], \ldots, e_{n} \cdot\left[x_{1}, \ldots, x_{n}\right]\right]=\left[x_{1}, \ldots, x_{n}\right] . \tag{29}
\end{align*}
$$

Denote the stabilizer of $e_{2}, \ldots, e_{n}$ in $G^{n}$ by $G^{1}$. If $\left[y_{1}, \ldots, y_{n}\right] \in G^{1}$ then, by the definition of the stabilizer,

e_{i} \cdot\left[y_{1}, \cdots, y_{n}\right]=e_{i}, \text { for } i \in\{2, \ldots, n\} .
$$

Consequently, reckoning with (29), the stabilizer $G^{1}$ consists of the elements

$\operatorname{Put}\left[y_{1}\right]=\left[y_{1}, e_{2}, \ldots, e_{n}\right]$, then

a \cdot\left[y_{1}, e_{2}, \ldots, e_{n}\right]=a \cdot\left[y_{1}\right], e_{1} \cdot\left[y_{1}\right]=y_{1} \text { and } e_{i} \cdot\left[y_{1}\right]=e_{i}, \text { where } i>1 . \tag{30}
\end{equation*}
$$

The following equality holds in $G^{1}$ :

\left[x_{1}\right]\left[y_{1}\right]=\left[x_{1}, e_{2}, \ldots, e_{n}\right]\left[y_{1}, e_{2}, \ldots, e_{n}\right]=\left[x_{1} y_{1}, e_{2}, \ldots, e_{n}\right]=\left[x_{1} y_{1}\right] .
$$

Basing on it, determine the inverse $x_{1}^{-1}$ for $x_{1}$ :

\left[x_{1}^{-1}\right]=\left[x_{1}\right]^{-1}=\left[x_{1}, e_{2}, \ldots, e_{n}\right]^{-1}
$$

Thus, we have transferred the structure of the group $G^{1}$ to the set $G$ itself and have obtained a group $G$ in which the multiplication is written without a dot. Then we
can state that (30) implies identity (5) in definition 6, i.e., the elements $e_{i}$ for $i>1$ are left zeros for the elements of $G$.

Now, denote by $G_{i}^{2}$ the stabilizer of the elements

$$
e_{2}, \ldots, e_{i-1}, e_{i+1}, \ldots, e_{n}
$$

in $G^{n}$. It is easily to see that every element in $G_{i}^{2}$ looks as $\left[x_{1}, e_{2}, \ldots x_{i}, \ldots, e_{n}\right]$ for some $x_{1}, x_{i} \in G$. Introduce the following notation for elements of $G_{i}^{2}$ :

In the stabilizer $G_{i}^{2}$, the element $\left[e_{1}, e_{i}\right]_{i}$ is neutral, and $\left[e_{i}, e_{1}\right]_{i} \in G_{i}^{2}$ is an involution:

Note that $\phi_{i}\left(e_{1}\right)=e_{i}$.

On the other hand, with account taken of (31), we get

Thus,

Acting at an element $a \in G$ by both sides of the equality, we obtain expression (2) from definition 6 .

Since this identity is obtained on the local group $G^{n}$, condition (2) of definition 6 is fulfilled.
$2^{0}$. Consider $x_{i} \in G$ for which $\phi_{i}\left(x_{i}^{-1}\right), E \phi_{i}\left(x_{i}^{-1}\right) \in U$, and (32) can be considered at the action on $E \phi_{i}\left(x_{i}^{-1}\right)$. Then, taking (30) into account, on the one hand, we have

and on the other hand, we obtain

Consequently,

$$

from which we get identity (4) of Definition 6.
$3^{0}$. For provving Assertion (3) of Definition 6, given arbitrary $X=\left[x_{1}, \ldots, x_{n}\right] \in$ $G^{n}$, construct the element $X_{i j} \in G^{n}$ obtained from $X$ by interchanging $x_{i}$ and $x_{j}$. It follows from (29) that

E_{i j} X=X_{i j}, \text { where } E_{i j}=\left[e_{1}, \ldots, e_{n}\right]_{i j} .
$$

On the other hand, $E_{1 i}^{2}=E=\left[e_{1}, \ldots, e_{n}\right]$, for $i \in\{2, \ldots, n\}$ and

$$
E_{1 i} E_{1 j} E_{1 i}=E_{1 j} E_{1 i} E_{1 j} \text { at } i \neq j .
$$

In addition to the above-introduced $\phi_{i}(x)=x \cdot E_{1 i}, x \in G$, define $\varepsilon_{i j}: G \rightarrow G$ as

\varepsilon_{i j}(x)=x \cdot E_{i j}=x \cdot E_{1 j} E_{1 i} E_{1 j}=\varphi_{j} \varphi_{i} \varphi_{j}(x)
$$

Then, for arbitrary $x \in U, y \in \phi_{i}(U) \cap U$, we have

$$
x \cdot\left[y, e_{2}, \ldots, e_{n}\right] E_{i j}=x \cdot E_{i j} E_{i j}\left[y, e_{2}, \ldots, e_{n}\right] E_{i j}=x \cdot E_{i j}\left[\varepsilon_{i j}(y), e_{2}, \ldots, e_{n}\right],
$$

and so we arrive at the equality

$$
\varepsilon_{i j}(x y)=\varepsilon_{i j}(x) \varepsilon_{i j}(y)
$$

Therefore, $\varepsilon_{i j}$ belongs to the group of automorphisms of the local group $G$, which leads us to the fulfilment of condition (3) of Definition 6.
The theorem is proved.
Thus, we have constructed the map

$$
F_{1}:\left(G, T_{n}\right) \rightarrow\left\langle G, \phi_{2}, \ldots, \phi_{n}\right\rangle,
$$

which associates with a local group of transformations $\left(G, T_{n}\right)$ the corresponding local $n$-pseudofield.

### 3.6 Categorical equivalence

Definition 7 For any class of algebras $K \mathfrak{A}$, denote by $\bar{K} \mathfrak{A}$ the category whose objects are algebras $\mathfrak{A} \in K \mathfrak{A}$ and morphisms are homomorphisms of algebras.

Let us now give the definition of an equivalence of categories (see [16, §4.4]):
Definition 8 A functor $\overline{F_{2}}: \bar{K} \mathfrak{A}_{1} \rightarrow \bar{K} \mathfrak{A}_{2}$ is called an equivalence of categories and the categories $\bar{K} \mathfrak{A}_{1}$ and $\bar{K} \mathfrak{A}_{2}$ are called equivalent if there is an (opposed) functor $\overline{F_{1}}: \bar{K} \mathfrak{A}_{2} \rightarrow \bar{K} \mathfrak{A}_{1}$ and natural isomorphisms:

\overline{F_{1}} \overline{F_{2}} \cong I: \bar{K} \mathfrak{A}_{1} \rightarrow \bar{K} \mathfrak{A}_{1} \text { and } \overline{F_{2}} \overline{F_{1}} \cong I: \bar{K} \mathfrak{A}_{2} \rightarrow \bar{K} \mathfrak{A}_{2} .
$$

Henceforth we will consider the group of transformations ( $G, G^{n}$ ) as a two-sorted algebra $\left\langle G, G^{n} ; \bullet, g, E\right\rangle$, where $g: G^{n} \times G^{n} \rightarrow G^{n}$ is the group operation, $E$ is the unary operation of taking the inverse in $G^{n}$. The action of the group $G^{n}$ on the topological space $G$ is written as the multiplication

$$
(\bullet): G \times G^{n} \rightarrow G \text {. }
$$

Recall that a homomorphism of two groups of transformations

\left(G, G^{n}\right)=\left\langle G, G^{n} ; \bullet, g, E\right\rangle \text { and }\left(G^{\prime}, G^{\prime n}\right)=\left\langle G^{\prime}, G^{\prime n} ; \bullet \bullet^{\prime}, g^{\prime}, E^{\prime}\right\rangle
$$

is a pair of mapppings

\mu: G \rightarrow G^{\prime} \text { and } \lambda: G^{n} \rightarrow G^{\prime n}
$$

such that the diagrams

commute.
Regard a local $n$-pseudofield $\left\langle G, \varphi_{2}, \ldots, \varphi_{n}\right\rangle$ as the algebra $\left\langle G ; \cdot{ }^{-1}, \varphi_{2}, \ldots, \varphi_{n}\right\rangle$.
Let $K \mathfrak{A}_{2}=K\left\langle G, G^{n} ; \bullet, g, E\right\rangle$ and $K \mathfrak{A}_{1}=K\left\langle G ; \cdot,^{-1}, \varphi_{2}, \ldots, \varphi_{n}\right\rangle$ be the classes of the algebras of local sharply $n$-transitive groups and local $n$-pseudofields.

Cconsider the categories $\bar{K} \mathfrak{A}_{2}, \bar{K} \mathfrak{A}_{1}$ whose objects are the corresponding algebras and whose morphisms are homomorphisms of algebras that preserve the numbers $n$ (these numbers are the degree of the pseudofield and the sharp transitivity degree of the local group of transformations).

Theorem 4 The category $\bar{K} \mathfrak{A}_{2}$ of local sharply $n$-transitive groups and and the category $\bar{K} \mathfrak{A}_{1}$ of local $n$-pseudofields are equivalent.
$1^{0}$. In Theorems 3 and 2, we constructed two mappings $F_{1}$ and $F_{2}$, and hence, for the corresponding functors $\overline{F_{1}}$ and $\overline{F_{2}}$, we constructed the mappings of the objects of the categories. It remains to define the mappings of morphisms of these categories.

For an arbitrary morphism $h \in \operatorname{mor}\left(\bar{K} \mathfrak{A}_{1}\right)$, from the corresponding algebras,

$$
\operatorname{dom} h=\left\langle G ; \cdot,^{-1}, \phi_{2}, \ldots, \phi_{n}\right\rangle \text { and } \operatorname{cod} h=\left\langle G^{h} ; \cdot \cdot^{h}, 1^{h}, \phi_{2}^{h}, \ldots, \phi_{n}^{h}\right\rangle,
$$

using $F_{2}$, construct their images

$$
\left\langle G, G^{n} ; \bullet, g, E\right\rangle \text { and }\left\langle G^{h},\left(G^{h}\right)^{n} ; \bullet^{\prime}, g^{\prime}, E^{\prime}\right\rangle .
$$

With account taken of the construction of the group operation $g$, using the tuple function, we conclude that, in the category $\bar{K}\left\langle G, G^{n} ; \bullet, g, E\right\rangle$ of transformation groups, the morphism $\overline{F_{2}}(h)$ is defined by the pair of morphisms

h: G \rightarrow G^{h} \text { and } h \times \ldots \times h: G^{n} \rightarrow\left(G^{h}\right)^{n}
$$

so that $\overline{F_{2}}(h)=(h, h \times \ldots \times h)$. Uder this mapping, the identity morphism is mapped to the identity morphism

\overline{F_{2}}: i d_{\mathfrak{A}_{1}} \mapsto i d_{\mathfrak{L}_{2}}
$$

and for arbitrary $f, h \in \operatorname{mor}\left(\bar{K} \mathfrak{A}_{1}\right)$, for which the composition $f \circ h$ is defined, the composition

$$

is also defined.
$2^{0}$. In the first part of Theorem 3, choosing an arbitrary collection $\left[e_{1}, \ldots\right.$, $\left.e_{n}\right]=\mathbf{e} \in G^{n}$, we passed to the isomorphic group

\left(i d, f_{e}\right):\left\langle G, T_{n} ; \bullet, \cdot,^{-1}\right\rangle \mapsto\left\langle G, G^{n} ; \bullet, g, E\right\rangle .
$$

For arbitrary homomorphic groups of transformations such that

(\mu, \lambda):\left\langle G, T_{n} ; \bullet, \cdot,^{-1}\right\rangle \mapsto\left\langle G^{\prime}, T_{n}^{\prime} ; \bullet^{\prime}, .^{\prime},{ }^{-1^{\prime}}\right\rangle
$$

fixing collections $\mathbf{e} \in G^{n}, \mathbf{e}^{\prime} \in G^{\prime n}$, construct the isomorphic groups

$$
\begin{aligned}
\left(i d, f_{\mathrm{e}}\right):\left\langle G, T_{n} ; \bullet, \cdot,^{-1}\right\rangle & \rightarrow\left\langle G, G^{n} ; \bullet, g, E\right\rangle, \\
\left(i d, f_{\mathrm{e}^{\prime}}\right):\left\langle G^{\prime}, T_{n}^{\prime} ; \bullet^{\prime}, .^{\prime},,^{1^{\prime}}\right\rangle & \rightarrow\left\langle G^{\prime}, G^{\prime n} ; \bullet^{\prime}, g^{\prime}, E^{\prime}\right\rangle .
\end{aligned}
$$

Then the mapping $\left(\mu^{\prime}, \lambda^{\prime}\right)=\left(i d, f_{\mathbf{e}^{\prime}}\right)(\mu, \lambda)\left(i d, f_{\mathbf{e}}\right)^{-1}$ is a homomorphism of the groups $\left\langle G, G^{n} ; \bullet, g, E\right\rangle \rightarrow\left\langle G^{\prime}, G^{\prime n} ; \bullet^{\prime}, g^{\prime}, E^{\prime}\right\rangle$, and the diagram

&\left\langle G, G^{n} ; \bullet, g, E\right\rangle \xrightarrow{\left(i d, f_{\mathbf{e}}\right)^{-1}}\left\langle G, T_{n} ; \bullet, \cdot,^{-1}\right\rangle \\

&\left\langle i d, f_{\mathrm{e}^{\prime}}\right)(\mu, \lambda)\left(i d, f_{\mathbf{e}}\right)^{-1} \downarrow

commutes.
In Theorem 3, from the group $\left\langle G, G^{n} ; \bullet, g, E\right\rangle$, we constructed an $n$-pseudofield $\left\langle G ; \cdot,^{-1}, \phi_{2}, \ldots, \phi_{n}\right\rangle$. Denoting this mapping by $f_{1}$, represent $F_{1}$ as the composition $F_{1}=f_{1} \circ\left(i d, f_{\mathbf{e}}\right)$ so that the following diagram holds:


The mapping $F_{2}$ of Theorem 2 is inverse to $f_{1}$. We have the commutative diagram

&\left.\left\langle G^{\prime}, G^{\prime n} ; \bullet^{\prime}, g^{\prime}, E^{\prime}\right\rangle \xrightarrow{f_{1}}\left\langle G^{\prime} ; \cdot^{\prime}, \mu^{\prime}, \lambda^{\prime}\right) \circ f_{1}^{-1}, \phi_{2}^{\prime}, \ldots, \phi_{n}^{\prime}\right\rangle,
\end{aligned}

where the morphism $f_{1} \circ\left(\mu^{\prime}, \lambda^{\prime}\right) \circ f_{1}^{-1}$ defines the morphism of the corresponding algebras. Thus, we have constructed the mapping $\overline{F_{1}}:\left(\mu^{\prime}, \lambda^{\prime}\right) \rightarrow f_{1} \circ\left(\mu^{\prime}, \lambda^{\prime}\right) \circ f_{1}^{-1}$. This mapping takes the identity morphism in $\bar{K} \mathfrak{A}_{2}$ to the identity morphism in $\bar{K} \mathfrak{A}_{1}$. If

$$
\left(f_{1}, f_{2}\right),\left(h_{1}, h_{2}\right) \in \operatorname{mor}\left(\bar{K} \mathfrak{A}_{2}\right)
$$

and the composition $\left(f_{1}, f_{2}\right) \circ\left(h_{1}, h_{2}\right)$ is defined then

$$
\overline{F_{1}}\left(\left(f_{1}, f_{2}\right) \circ\left(h_{1}, h_{2}\right)\right)=\overline{F_{1}}\left(f_{1}, f_{2}\right) \circ \overline{F_{1}}\left(h_{1}, h_{2}\right)
$$

is also defined. Considering the compositions of the mappings $F_{1}$ and $F_{2}$ of Theorems 3 and 2:

$$
F_{1} \circ F_{2}\left(\left\langle G ; \cdot,^{-1}, \varphi_{2}, \ldots, \varphi_{n}\right\rangle\right)=F_{1}\left(\left\langle G, G^{n} ; g, E\right\rangle\right)=\left\langle G ; \cdot,^{-1}, \phi_{2}, \ldots, \phi_{n}\right\rangle
$$

and

$$
F_{2} \circ F_{1}\left(\left\langle G, T_{n} ; \bullet, \cdot,^{-1}\right\rangle\right)=F_{2}\left(\left\langle G ; \cdot,^{-1}, \phi_{2}, \ldots, \phi_{n}\right\rangle\right)=\left\langle G, G^{n} ; g, E\right\rangle,
$$

we come to a natural isomorphism $\overline{F_{1}} \circ \overline{F_{2}} \cong I$ and $\overline{F_{2}} \circ \overline{F_{1}} \cong I$.
The theorem is proved.

## 4 Conclusion

The paper shows that local sharply $n$-transitive groups can be constructed over simpler objects - local $n$-pseudofields, which are proved to be categorically equivalent.

In conclusion, we want to formulate some problems:

1. Let $G$ be a Lie group. Classify functions $\varphi: G \rightarrow G$ (possibly, defined only on an open subset) such that
(a) $\varphi(\varphi(x) \varphi(y))=\varphi(x \varphi(E(y))) y$,
(b) $\varphi(\varphi(x))=x$,
(c) $\varphi E \varphi(x)=E \varphi E(x)$.
2. At present, the authors are familiar with a classification ${ }^{3}$ of local sharply $n$-transitive groups of transformations of the set $\mathbb{R}^{2}$ [19, 20]. There arises the problem of: as a minimum, to find possible 2-pseudofields over 3D groups, and as a maximum, to construct a classification of local $n$-pseudofields for subsequently constructing the corresponding local $n$-transitive groups of transformations of $\mathbb{R}^{3}$.
3. A more general task is to find the constraints imposed on the Lie algebras for local sharply $n$-transitive groups of transformations when they are associated with the corresponding local $n$-pseudofields.
